ARTICLE I
Water Authority
[Adopted 8-7-1951 as Ord. No. 229]

§ 3-1. Intention and desire to organize.

The Borough Council hereby signifies its intention and desire to organize an Authority under the provisions of the Municipality Authorities Act of 1945, as amended.¹

§ 3-2. Articles of Incorporation.

The Mayor, the President of the Borough Council and the Secretary are hereby authorized and directed to execute, on behalf of the Borough of North Wales, Articles of Incorporation for said Authority.²

§ 3-3. Initial project.

The initial project which shall be undertaken by said Authority is to acquire, hold, construct, improve, maintain, operate, own and lease, either as lessor or lessee, waterworks, water supply works and water distribution systems in the Borough of North Wales and such other territory as it may be authorized to serve.

§ 3-4. Appointment of first members.

The following named persons be and they hereby are appointed as the first members of the Board of the Authority, whose terms of office shall commence on the date of appointment and shall be computed from January 1, 1952.³

§ 3-5. Second project. [Added 11-13-1962 by Ord. No. 322]

Authority is hereby given to the second project of the North Wales Water Authority; namely, to acquire, hold, construct, improve, maintain, operate, own and lease, either as lessor or lessee, waterworks, water supply works and water distribution systems in Montgomery Township, Montgomery County, Pennsylvania, and to introduce its facilities and service in said township at its own discretion.

§ 3-6. Decisions regarding second project vested in Authority. [Added 11-13-1962 by Ord. No. 322]

The decision as to the manner, location and type of facilities and service and the time of introduction and the control thereof shall be at all times in the discretion of the North Wales Water Authority.

§ 3-7. Third project. [Added 4-9-1963 by Ord. No. 329]

Approval is hereby given to the third project of the North Wales Water Authority; namely, to acquire, hold, construct, improve, maintain, operate, own and lease, either as lessor or lessee, waterworks, water supply works and water distribution systems in Worcester Township, Montgomery County, Pennsylvania, and to introduce its facilities and service in said township at its own discretion.

§ 3-8. Decisions regarding third project vested in Authority. [Added 4-9-1963 by Ord. No. 329]

The decision as to the manner, location and type of facilities and service and the time of introduction and the control thereof shall be at all times in the discretion of the North Wales Water Authority.
