

2019 Annual Review

2019 Accomplishments

2019 was the first full year after the adoption of the North Wales Borough 2040 Comprehensive Plan. Borough administration, the Planning Commission, and its consultants worked on a number of projects to advance the goals and recommendations identified in the comprehensive plan. Workshops were established and held prior to planning commission meetings to discuss work items relating to the comprehensive plan implementation. These workshops are open to the public.

Ordinance Amendments

- Update to the Transit Oriented Development zoning district
 - The PC worked with MCPC on identifying updates to the TOD district. Multiple rounds of updates were conducted and site build-out analysis was conducted to test limits of the proposed zoning code. Updates to this ordinance are being finalized with the intent to have Borough Council adopt the zoning text update in early 2020.

Studies and Projects

- Center Street Connectivity Project
 - o The borough was awarded PECO Green Region grant funding to conduct preliminary engineering analysis of the necessary construction costs and right-of-way acquisition for the Center Street Project. The borough anticipates applying for Montco2040 grant funding in spring 2020.
- Tree Restoration Project
 - The borough applied for the bonus PECO Green Region grant in the fall of 2019 for a tree planting project that would replace dead and dying trees around Borough Hall and in Weingartner Park with additional native species to improve the aesthetics and ecological functioning of these public open spaces. The borough will receive notification of the grant award in 2020, with an anticipated completion date, if selected, of fall 2020.

At their meeting of February 5, 2020, the Planning Commission reviewed the priority projects and implementation timeline in the Borough's 2040 Comprehensive Plan and identified a list of high priority projects for 2020. The Planning Commission voted 5-0 to submit this list of 2020 Work Items to Council for consideration at their February 25th meeting.

Specifically, the Planning Commission is seeking authorization from Borough Council to work on the following projects with MCPC during the 2020 calendar year:

- Conduct an audit of the Zoning and Subdivision and Land Development Ordinances to identify necessary updates for clarification of intent, appropriateness of districts, and preservation or protection of existing community character.
- Conduct an audit of permit parking in the Borough and evaluate establishing a fee-based annual permit parking program.
- Conduct a Borough-wide walkability audit to evaluate sidewalk and crosswalk conditions.

In addition, the Planning Commission is requesting that Council designate the responsible Borough agencies to address the studies and projects as assigned on the 2020 Work Items list.

Proposed Work Items

In reviewing the priority projects and implementation timeline in the Comprehensive Plan, the following projects were identified as either high priority projects and/or projects with a short-term (0-5 year) time frame for implementation. Included below each item is a list of the responsible agencies recommended in the implementation plan. These groups should be tasked with addressing each of these projects, but Borough Council may determine other individuals, agencies, or committees should be included on the project team in addition to or instead of those agencies recommended below. MCPC will offer their assistance to Borough groups and committees tasked with these projects to provide guidance on project scope and outcomes. The following projects have been reviewed and recommended by the Borough Planning Commission for authorization by Borough Council.

Ordinance Amendments

- Conduct an audit of the Zoning and Subdivision and Land Development ordinances to identify necessary updates for clarification of intent, appropriateness of districts, and preservation or protection of existing community character.
 - o Responsible agencies: NW Planning Commission, MCPC
 - o MCPC will work with Borough staff to identify areas of both the Zoning Ordinance and the SALDO that should be updated to reflect best planning practices, address any inconsistencies, and strengthen regulatory requirements to achieve the Borough's planning objectives outlined in the Comprehensive Plan. These recommended amendments will be prepared in "batches" that will group similar or connected amendments together for ease of review and adoption rather than proposing all changes simultaneously. This will allow for improved communications about the changes and opportunities for public input.
- Finalize zoning text amendments to the TOD District.
 - o Responsible agencies: NW Planning Commission, MCPC
 - The Planning Commission and the MCPC have been working on "right-sizing" the TOD District zoning language throughout 2019. Changes to this ordinance will be finalized and presented to Borough Council for review in March 2020.

Studies and Projects

- Apply for Montco2040 funding for the Center Street Project to supply construction costs for the sidewalk and gateway.
 - o Responsible agencies: NW Planning Commission, MCPC, Borough Engineer
 - The MCPC is assisting the borough in writing the grant application for this funding source (applications are due March 1, 2020). This project was placed on hold last year for additional

engineering, which is being completed under a secondary grant from PECO Green Region. These efforts will create a more "shovel-ready" project, and consists of building a sidewalk on Center Street connecting Walnut Street to the gateway into Parkside Place Park. A new gateway feature will formalize the pathway entrance, and lighting, crosswalks, and new ADA curb ramps will improve pedestrian visibility and safety.

- Conduct a park access audit to identify opportunities and challenges to access at each of the parks.
 - o Responsible agencies: Parks & Recreation Board
 - The Borough has numerous parks, but not all are fully ADA accessible, and some may not offer amenities desired by the community, such as seating, tables, or recreational amenities. The park access audit is intended to better understand usage at the parks, determine community needs and desires for the parks, and assess the pedestrian and vehicular access to the parks to optimize their utilization and function for the community.
- Complete a street tree inventory including identification of priority locations for future planting projects. Include a maintenance and funding plan to manage and replace aging trees.
 - o Responsible agencies: Shade Tree Commission
 - Street trees play an important ecological and aesthetic function in the community. The inventory is intended to create a registry of all existing trees to catalog their location, species, and health condition. Educational materials should be provided to property owners for best maintenance practices to protect the health of trees, identify trees that have reached the end of their life cycle and should be replaced, and identify locations without trees where new street trees should be located.
- Create a future use plan for St. Luke's Church.
 - o Responsible agencies: North Penn Arts Alliance, MCPC, Borough Administration
 - The Borough should coordinate with the Arts Alliance to determine the desired future use of the space, internal or external improvements to the facilities, and scheduling needs.
- Conduct an audit of permit parking in the Borough and establish a fee-based annual parking permit program.
 - o Responsible agencies: NW Planning Commission, MCPC
 - O Portions of the Borough around the train station have on-street permit parking. This audit will document current parking demands on these streets to better understand the efficacy of the permit program, and make recommendations for its administration, which may include a recommendation to apply a small parking fee.
- Conduct a Borough-wide walkability audit to evaluate sidewalk and crosswalk conditions.
 - o Responsible agencies: NW Planning Commission, Borough Public Works, MCPC
 - The Borough has a robust sidewalk network, but some areas have broken or incomplete sidewalk infrastructure. The audit will explore every street in the Borough to catalog existing conditions of

sidewalks, crosswalks, curb ramps, and other pedestrian infrastructure, and will provide improvement recommendations.

- Notify property owners of overgrown vegetation impeding sidewalk access.
 - o Responsible agencies: Borough Code Enforcement
 - o To ensure pedestrian mobility is not hindered by overgrown brush, the Borough should issue notification of improperly maintained vegetation to property owners. Some of these violations will likely be identified through the walkability audit.

A RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION FOR THE 2020 ROUND OF THE MONTCO 2040 IMPLEMENTATION GRANT PROGRAM FOR THE CENTER STREET PEDESTRIAN CONNECTION AND GATEWAY PROJECT

WHEREAS, Montgomery County has established the Montco 2040 Implementation Grant Program as a competitive funding program to assist municipalities in implementing the goals of the county comprehensive plan, *Montco 2040: A Shared Vision*; and

WHEREAS, the County is accepting applications for projects that advance specific goals under either of the county comprehensive plan's three themes: Connecting Communities, Sustainable Places, and a Vibrant Economy; and

WHEREAS, applications and projects must meet all stated requirements within the Montco 2040 Implementation Grant Program Guidebook; and

WHEREAS, North Wales Borough wishes to obtain \$154,725 from the Montco 2040 Implementation Grant Program to provide funding to undertake the Center Street Pedestrian Connection and Gateway project; and

WHEREAS, this project has been identified as a high priority by the North Wales Borough 2040 Comprehensive Plan.

NOW, THEREFORE, BE IT RESOLVED, that the BOROUGH COUNCIL OF THE BOROUGH OF NORTH WALES hereby approves this project and authorizes application to the Montco 2040 Implementation Grant Program in the amount of \$154,725; and

BE IT FURTHER RESOLVED, that if the application is granted, the Borough commits to the expenditure of matching funds in the amount of \$32,445, plus \$7,500 awarded to the Borough by the PECO Green Region Grant Program, for a total match offer of \$39,945 necessary for the project's success.

MONTCO 2040: IMPLEMENTATION GRANT PROGRAM

As part of the implementation of the county's comprehensive plan, Montco 2040: A Shared Vision, the county has established a grant program for municipalities to make targeted physical improvements that achieve real progress toward the goals of the plan. The program offers the opportunity to move general themes and issues at the countywide level into specific improvements at the local level that transforms planning into action. Specific Focus Categories that reflect recent county planning initiatives are highlighted and emphasized each year.

PROJECT REQUIREMENTS

- Maximum grant award is \$200,000, but average award may be closer to \$100,000
- Minimum local match is 20% of the grant amount—other funding sources and greater matches are encouraged. Open Space Preservation projects require a 50% minimum local match
- Projects must specifically address a stated goal within the three themes of the comprehensive plan: Connected Communities, Sustainable Places, and Vibrant Economy
- Projects that fall under a Focus Category will receive greater consideration during the application review
- Grant award may only be applied to physical improvements, i.e. construction, infrastructure/site work, materials, land acquisition
- Grants will be disbursed as reimbursements for eligible costs
- Project length is limited to 24 months from the date a grant is awarded

PROCESS

- Funding for 2020 will commence with an application deadline of March 1, 2020. A second round is not anticipated, but an announcement will be made if this changes
- A committee consisting of Planning Commission Board Members, Planning Commission Staff, and Interdepartmental County Staff will score and review applications on a competitive basis
- Recommendations of funding will be forwarded to the County Commissioners for action
- Funding agreements to be issued to municipalities upon Commissioner approval
- Agreements will be administered by the County's Department of Housing and Community Development

WHO CAN APPLY?

- Applications must be submitted and administered by municipalities, but they may join with non-profit or private entities to achieve a public benefit
- Municipalities may submit two applications, but are eligible to receive only one grant award unless part of a multi-municipal project

PROJECT REVIEW CRITERIA

- Impact of Project—Extent of the project's benefit, transformative ability, longevity, visibility, and educational component
- County Planning Consistency—Credit for municipalities with current county planning assistance contracts, projects that connect to county-owned assets, and follow county policies or plans
- Local Planning Consistency—Consistency with current local plans
- Project Readiness—Design or engineering work completed, permits obtained, other agency coordination
- Funding—Percent and type of matching funds, commitment of local contribution, other funding sources

NEW FOR 2020:

- Municipalities may submit two applications (maximum of one award)
- Open Space Preservation projects added to the Adaptation and Resiliency Focus Category
- Follow the principles of the county's Complete Streets Policy and Health in All Policies when applicable

FOCUS CATEGORIES—2020

Focus Categories will be announced each year by the county's Planning Commission in order to encourage specific project types that address current initiatives and issues in Montgomery County. In 2020, all three of the prior focus categories will remain.

ADAPTATION
AND
RESILIENCY

Continued growth and development in the county coupled with climate change and extreme weather events accelerates the decline of natural systems and ultimately threatens public health and quality of life. Communities must adapt to these changes and become

This category intends to support the most needed projects that help protect against or recover from negative environmental changes. Applicants should be prepared

more resilient to better sustain their futures.

to demonstrate the extent of the problem being addressed and the success of its proposed actions. Municipalities may need to reference their MS4,TMDL, PRP, Stormwater Management Plan or Hazard Mitigation Plan for competitive projects. Potential projects include:

 Floodplain Mitigation – Reduce the impact of flooding through an emergency services flood warning system, removal or retrofit of structures in the floodplain, installation of flood control structures, and natural resources protection

 Streambank Restoration – Rapid erosion and changing courses can impact floodplains, increase pollution, and damage ecosystems. Identify the cause of streambank degradation and implement appropriate naturalization techniques

Retrofit Municipal or School District Property with Stormwater BMPs – Address
 critical flooding or erosion issues with naturalized basins, vegetated swales, rain gardens, porous pavement,
 stormwater extended detention ponds, and constructed wetlands

 Green Streets – Incorporate landscaped areas and tree canopy designed as stormwater BMPs to promote runoff infiltration and filtering of pollutants. Other components include stormwater curb extensions, planters, vegetated swales, rain gardens, and street tree planting

 Community Gardens – Utilizing vacant lots or excess land for gardening can promote localized food production, encourage healthy eating habits, reduce pesticide and fossil fuel use, and connect residents to where their food comes from



Conserving natural resources and environmentally-sensitive areas can help maintain ecosystems, improve water quality, reduce flooding, provide needed buffers to developing areas, or provide recreation opportunities. Desirable projects may protect critical conservation areas, promote active tourism, increase opportunities to exercise, or green the county's towns. Open Space Preservation projects are required to have a minimum 50% local match, which may come from any combination of municipal or outside funding sources.

WALK
AND BIKE
MONTCO—TRAILS,
PATHS, SIDEWALK
CONNECTIONS AND
BIKE FACILITIES

Walkability is more than a buzzword and making our communities more walkable is a winning proposition. It provides transportation choices, improves health, creates better community connections, makes the county more appealing for young workers, and improves the environment. Biking also provides a healthy alternative to getting around, but all too often the effort is made difficult by streets designed solely for the automobile.

This category is connected to the county's adopted Walk Montco and Bike Montco plans. Areas that currently impede the ability to walk or bike through insufficient design, lack of facilities, or dangerous conditions should be targeted. Potential projects include:

- Improvements that create safer conditions in and around popular school routes, downtown business areas, suburban commercial areas, or public transit facilities
- New trails, paths, or sidewalks that opens access to other trail or park connections from a neighborhood or employment area
- Road diets incorporating some combination of bicycle lanes, landscaped medians, rain gardens, on-street parking, crosswalks, sidewalks, other BMPs, and traffic calming elements
- On-road bicycle facilities such as sharrows, standard bicycle lanes, or protected bicycle lanes either on or near Bike Montco's planned bicycle network
- Off-road bicycle facilities such as bike racks or bike sharing systems
- Pedestrian-oriented wayfinding signage
- Trailheads with parking and signage

When applicable, projects should include the principles of the county's Complete Streets Policy and Health in All Policies, available on the web at montcopa.org/completestreetspolicy

Mixed use areas with thriving businesses, cultural venues, libraries, green infrastructure, and urban parks provide places for people to gather and make connections with their community while improving the quality of life for surrounding neighborhoods. This category enables communities to facilitate the development of their downtowns and community destinations in a manner that supports a central business district while emphasizing physical activity and social connections. There are many creative ways to approach this goal, including but not limited to, these potential ideas:

SUPPORT
DOWNTOWNS
AND COMMUNITY
DESTINATIONS

- Create or improve public gathering spaces, such as plazas, within the business district
- Connect or improve downtown pocket-parks or urban parks in the vicinity of a downtown
- Improve the identity of a downtown and its surrounding neighborhoods with unique public improvements, such as public art, wayfinding signage, or other place-making installations
- Urban greening improvements such as green roofs, living walls, rain gardens, and plantings
- Enhance the function or prominence of a cultural venue through exterior physical improvements
- Library improvement projects that enhance physical connectivity through improved public facilities, such as community spaces, outdoor plazas, or other locational improvements

GENERAL PROJECT CATEGORIES

Eligible projects need to address a stated goal in the county comprehensive plan. This provides a wide range of potential projects, but they must result in physical improvements or acquisitions that further both local and county goals. The greater the reach and impact of a project will result in a higher likelihood of funding. Opposite is a generalized list of potential projects as they connect to the comprehensive plans themes and goals. They represent the most obvious connections between goals and improvements, but the list should not be considered finite. Creative and effective projects that still address the goals are welcome for consideration.



President Sando led the Pledge of Allegiance.

Public Comment

Pat Graham, 324 South Fourth Street, stated she stopped into the Borough offices to report that a few Boxelder trees behind her house in Weingartner Park are being eaten by squirrels. Manager Hart stated she notified Public Works to check the trees to see what remedy is required.

Andrew Berenson, 439 Washington Avenue, asked why Council is not using the microphone system for the meeting. President Sando stated Council is not using the microphone system at the moment because of technical difficulties.

Ruth Black, 401 South Main Street, asked if the Borough has a law that prohibits the use of air brakes on Main Street and requested that one be implemented if the Borough does not have one. Chief Eves stated he would check to see if we have an Ordinance in place. Solicitor Gifford stated the Borough would have to adopt an Ordinance if one is not in place.

Jocelyn Tenney, 801 East Walnut Street, asked when the Technology Committee will be meeting to resolve issues relating to the microphone system. Member Collins stated he just received information on the system and the Technology Committee will be meeting soon to discuss the issues.

Andrew Berenson, 439 Washington Avenue, asked why Solicitor Gifford needs to discuss alleyways in private. Solicitor Gifford stated he is not authorized to provide legal advice in public because it could allow for someone to exploit his advice.

Manager Hart reviewed the list of Boards and Commissions vacancies. She then announced at an upcoming Council meeting, Council will authorize an official proclamation to endorse the 2020 U.S. Census. She then announced that everyone should have received their tax bills in the mail for County and Borough Real Estate taxes. She then reviewed the list of upcoming historical events being hosted by local historical societies and upcoming events being hosted by the North Penn Arts Alliance at the North Wales Arts and Cultural Center.




